

Condor Disposals & Destructions

Track and manage data destruction and disposal in compliance relevant legislation.

The Condor Disposal & Destructions has been specially designed to assist organisations in compliance with Commonwealth and State Records Acts, Privacy laws and other relevant legislation governing how agencies must manage sensitive data, including the Telecommunications (Interception and Access) Act and Surveillance Device acts. It not only tracks and manages disposal and destructions of record data and attachments, but can also fully destroy the related audit records, enabling full compliance.

This add-on tool will be especially valuable to clients utilising the Condor Compliance module for management of covert powers, but can be deployed in any Condor suite where there is a need to manage retention and disposal of data.



1. Track records in scope for retention or destruction

Condor Disposal & Destructions enables easy compilation of records and attachments in scope, including the ability to add candidates to the list. All Condor records including matters, activities, entities, attachment and any child records can be included in scope. Each record can be individually assessed and recommended for retention or destruction.



2. Secure approvals and execution management

Necessary approvals for destruction can be configured to match your organisation's process. Review steps, approval chains, and oversight roles can all be accommodated with role-based security built into the workflow. Secure safeguards are also incorporated into the execution process to ensure that more than one person is always required to execute the destruction process.



3. Automatic or manual destruction

All records and attachments can be scheduled for automatic deletion or can be marked for manual redaction/deletion. Audit records, including data audit, event audits and bulk reports and audit reports are either deleted or all fields are nulled to ensure there is no trace of sensitive data remaining.



4. Complete and permanent deletion

All deletions are permanent and irreversible, with no mechanism available to restore any data modified or deleted using this tool, internally or by Distillery staff.



5. Accountability

Condor Disposal & Destructions helps ensure accountability and prove compliance, by providing a complete record of the disposal process, including all recommendation, approvals and actions.
